Ordinance / Resolution Number: 19-1375

Be it ordained/resolved by the **City of Woodburn Common Council** that for the expenses of **WOODBURN CIVIL CITY** for the year ending December 31, **2020** the sums herein specified are hereby appropriated and ordered set apart out of the several funds herein named and for the purposes herein specified, subject to the laws governing the same. 




