AN ORDINANCE OF THE CITY OF WOODBURN, INDIANA COMMON COUNCIL AMENDING CHAPTER 152 AND CHAPTER 154 OF THE CITY OF WOODBURN, STATE OF INDIANA, ORDINANCE

WHEREAS, the City Council of the City of Woodburn (the "City"), State of Indiana, pursuant to Indiana Code Section 36-7 et. seq., as amended, has authority to plan for and regulate the use and zoning of real property located within its municipal boundaries; and,

WHEREAS, the City Council desires to update the City zoning ordinance by aligning it with Allen County and the City of Fort Wayne zoning ordinances, and

WHEREAS, the Allen County Plan Commission serves as the Plan Commission for the City; and,

WHEREAS, the Allen County Department of Planning Services serves as the Land Use staff for the City; and,

WHEREAS, the Allen County Department of Planning Services staff prepared the amendment titled ZORD-2019-0008 and presented it to the Plan Commission; and,

WHEREAS, the Allen County Plan Commission published the required notice and held a public hearing on this proposed text amendment on the 9th day of January, 2020; and.

WHEREAS, after deliberating, the Plan Commission resolved to recommend that the City:

- (1) Amend Chapter 152 of the City of Woodburn Code of Ordinances by adding (Planning and Development); and,
- (2) Amend Chapter 154 (Zoning Code) of the City of Woodburn Code of Ordinances [Sections 154.212 through 154.224 (Zoning Districts); Section 154.02 (Site Plan Review); Section 154.404 (Development Design Standards); Section 154.408 (Landscape Standards); and Sections 154.506 (Definitions)];

WHEREAS, the Allen County Plan Commission held a business meeting on the

16th day of January 2020 and took action on the submitted text amendments; and,

WHEREAS, the Allen County Plan Commission, pursuant to I.C. Section 36-7-4-605(a)(2), by a vote of 9-0, certified the proposed text amendments with a DO PASS recommendation to the Woodburn City Council;

NOW THEREFORE, BE IT ORDAINED by the Woodburn City Council that, as the legislative body of the City of Woodburn, Indiana, the City Council concurs with the Plan Commission's recommendation and hereby approves and adopts the replacement of Chapter 152; repeals Chapter 153; and, replaces Chapter 154 of the Woodburn Code of Ordinances, all as attached hereto.

PROJECT SUMMARY

The public hearing was held for the next part of the ongoing ordinance update and alignment project. This project began in April of 2009 with the Joint Land Use Governing Board recommendation to the Plan Commissions that initiated the project.

The fourth part of the project involved the completion and adoption of the replacement zoning ordinances. The replacement ordinances for the City of Fort Wayne and Allen County were approved in late 2013 and were effective as of April 4, 2014. The City of Woodburn zoning ordinance was also updated and aligned in 2018 with an effective date of March 3, 2018.

For this amendment, DPS staff identified the first substantive area that staff felt needed to be updated – the Landscape Standards. This set of amendments is proposed to improve the landscape plan review and approval process by:

- 1) Clarifying the landscape standards language;
- 2) Simplifying/reducing the number of landscape codes;
- 3) Aligning the development, landscape, and residential impact mitigation standards;
- 4) Addressing the other landscape standards issues, and related issues that have been identified since 2014; and
- 5) Aligning the Woodburn landscape standards with the previously updated County and Fort Wayne ordinances.

A summary of the proposed amendments follows (in Plan Commission packet); staff will be presenting an overview of the proposed amendments at the public hearing. The Town of Huntertown ordinance will be amended at the same time. Allen County and Fort Wayne ordinances have previously been amended. The effective date is proposed to be April 8, 2020.
