## ORDINANCE NO. <u>25-1431</u> CONCERNING THE FLOOD HAZARDS WITHIN THE CITY OF WOODBURN

WHEREAS, Allen County Ordinance No. 05-02-25-05 (Allen County Code Title 21) has been adopted concerning building and improvements in flood hazard areas; and

**WHEREAS**, jurisdictions desiring to participate in the National Flood Insurance Program are required to be covered by an ordinance such as Allen County Ordinance No. 05-02-25-05 (Allen County Code Title 21) and

**WHEREAS**, it is desirable that real estate located within the jurisdiction of the City of Woodburn be eligible for insurance available pursuant to the National Flood Insurance Program.

**NOW THEREFORE, BE IT ORDERED** that the City of Woodburn does hereby indicate its intention to maintain participation in the National Flood Insurance Program.

**BE IT FURTHER ORDAINED** that the City of Woodburn does hereby adopt by reference the provisions of Allen County Ordinance No. 05-02-25-05 (Allen County Code Title 21).

**BE IT FURTHER ORDAINED** that the appropriate agency of the City of Woodburn, Indiana maintain a copy of this ordinance, together with Allen County Ordinance No. 05-02-25-05 (Allen County Code Title 21) in the manner city ordinances are kept and available for public inspection.
